## **VIRGIE E. CAREY STUDENT AID FUND GUIDELINES**

Applicants must be a graduating senior in an accredited high school (Male or Female).

Applicant's grade point average (GPA) should be at least a **3.0 or "B."**

The recommending jurisdiction Grand Court/Guild Seal must be affixed on the application, along with the signature of the Royal Grand Princess Commandress/Grand Princess Captain and Royal Grand Secretary.

Recommending jurisdiction must submit a letter of recommendation with the Grand Court/Grand Guild Seal affixed, along with the signature of the Royal Grand Princess Commandress/Grand Princess Captain and Royal Grand Secretary.

Applicant must write an essay describing his/her community service, church, school activities and career objectives. This essay must be type-written and double-spaced in number 12 or 14 font and should not exceed two pages. Applicant must sign and date the essay and the application.

Sealed, unopened transcript from the school with the **Official School Seal** affixed.

Small photo, if available, should be affixed...but not required.

Application must be postmarked by the official deadline of **MAY 13th of each year.**

Any missing information will render the applicant ineligible.

Only one application per jurisdiction can be submitted for consideration.

Please make two (2) copies of everything, except the **Official Transcript** and submit completed application to:
